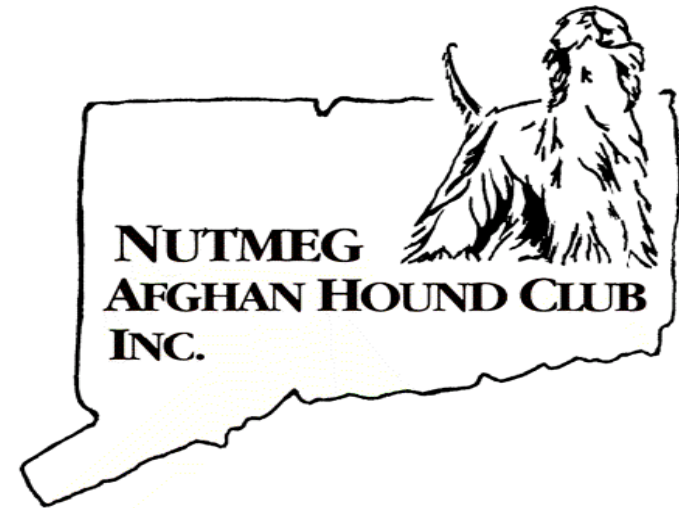

No dog with the UD title may compete in any Regular Class at an OA Sanctioned Match. Dogs with the UD title may be entered and participate in the Open B or Utility Classes, but may not compete for any awards in these classes.

Please read the Obedience rules carefully. Open and Utility Obedience entries MUST include jump height. Obedience entries will be arranged and judged in jump height order in all classes where jumps are used.

**From the East**—84W to Exit 62. At end of exit turn right. Proceed to the light at Buckland St. and turn right. Go straight, under the railroad bridge and bear left.. Tails-U-Win is immediately after Adams Mill Restaurant on the left. The entrance is in the back.

**From the West**-- 84E to Exit 62, At end of exit turn right onto Buckland St. Go straight, under the railroad bridge and bear left.. Tails-U-Win is immediately after Adams Mill Restaurant on the left. The entrance is in the back.

**From the North**-91S-Exit 35A-Rt 291 to Exit 5. At end of exit turn left. Take a right at Manchester Honda light. Go under the railroad bridge, and bear left. Tails-U-Win is immediately after Adams Mill Restaurant on the left. The entrance is in the back.

**From the South.** 91N to 84E. Follow **From the West directions**

I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this show or obedience trial, howsoever such injuries, death or damage to property may be caused, and whether or not the same may have been caused or may be alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other persons.

[2] The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

[3] (Dog Show Class) Consult the classification in this premium list. If the dog show class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.

[4] A dog must be entered in the name of the person who actually owned it at the time entries for a show closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any show for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name.
